ORDINANCE NO 403: It shall be unlawful for any person to knowingly take, receive, use or convert to such person's own use, or the use of another, any electricity, water, or natural gas which has not been measured or any telephone or cable television service which has not been authorized. It shall also be unlawful for any person to damage, molest, tamper with, obstruct or destroy any pipe, line, wire, meter or other part of any public utility....
